### **DIRECTIONS FOR MOVE-IN**

#### **From I-95:**

Take I-95 to the Okeechobee Boulevard exit (# 70) and head east on Okeechobee Boulevard, approximately 1 mile. The Palm Beach County Convention Center is located on the south side of Okeechobee Boulevard, directly across the street from CityPlace.

#### **From Florida's Turnpike:**

Take Florida's Turnpike to the West Palm Beach/Okeechobee Boulevard exit (# 99) and head east for approximately 7 miles. The Palm Beach County Convention Center is located on the south side of Okeechobee Boulevard, directly across the street from CityPlace.

Once you arrive at the Palm Beach Convention Center, please follow signs for the Loading Dock. At the Loading Dock there will be a ramp to park your vehicle and unload. This event will take place in Hall A, on the ground level, with access directly from the loading dock. Please unload your items into your booth and then move your vehicle to the General Parking. Please park your vehicle in the General Parking before setting up your booth to keep the dock open and allow other exhibitors to move-in. We ask that all exhibitors do their best to maintain social distancing during move-in and setup. There will be Palm Beach Convention Center Security present to answer any questions.

**Exhibitor identification badges will be available for pick-up during move-in.**
